GIRLS CAMP HEALTH POLICY 2025 - (required)

Hello, and thank you for showing interest in participating in our Girls Camps! Our aim is to offer a high-quality, exciting, safe, and healthy environment for all the Girls & adults that come to Camp Springville.

To ensure our ability to do so <u>we are reminding everyone that several aspects of our Girls Camps</u> <u>are now conforming to the camp policies of Camp Springville and the other district departments</u>. This includes our health policies.

Due to very close living conditions, major disruptions occur when there is a health problem. Persons with contagious health problems (i.e. impetigo, lice, etc.) must return home. Persons with contagious viruses require quarantine and other procedures, sometimes including return home. It is recommended that <u>your church personnel check for these situations very carefully *before* you leave to come to camp.</u>

When you arrive at camp, there are mandatory lice checks before anyone leaves registration and enters the camp. Please help us avoid embarrassing situations of having to either not admit or send individuals home. <u>Please check your adult volunteers and campers very carefully *before* coming</u>.

If, after completing registration and entering the camp, a person is found to have a contagious health problem that requires decontamination treatments of campers, volunteers, rooms, linens, etc., <u>the originating church will be asked to share the cost of the treatments</u>. For example, a minimum fee of \$30 will be assessed to the originating church <u>for each person</u> that must be treated for <u>exposure</u> to lice. Our health procedures require us to treat <u>all</u> individuals who <u>may</u> have been exposed. Our expenses include shampoos, sprays, laundering, fumigating, disinfectants, etc. There is a comprehensive treatment policy in place that <u>we must follow</u>, therefore the fee will not be decreased for any reason and may be increased depending on the severity of the situation.

These policies apply to <u>all</u> contagious health problems brought to camp that trigger the disinfecting treatment procedures. Thanks so much for checking and questioning your volunteers and campers <u>before</u> you come to camp to ensure they are ready for a fun and healthy camping experience. Thanks for helping us keep camp healthy!

This policy is effective for this 2025 camping season. Each group must have an adult representative sign this form. Thank you for your cooperation!

SPRINGVILLE CAMP and CONFERENCE CENTER DAMAGE POLICY 2025 – (required)

The following fees will be <u>charged to churches</u> for damages caused by their leaders, volunteers, campers, or other individuals associated with them:

- Writings on walls, ceilings, floors or beds that can be covered by paint alone. \$40 per square foot. (Minimum fee \$40)
- Writings on walls, ceilings, floors or beds that cannot be covered by paint alone (requiring filler or other work prior to painting). \$70 per square foot. (Minimum fee \$70)
- Hole in sheetrock wall. \$70 per square foot. (Minimum fee \$70)
- Broken window that can be fixed with glass alone. \$45
- Broken window with frame damage. \$75
- Broken sink or toilet. \$200
- Broken sink or toilet causing water damage to any part of the building. \$300
- Destruction of ceiling tiles. \$25 per tile.
- Damage to bunk beds or guard rails that can be repaired. \$50
- Destruction of bunk beds to the point they cannot be fixed. \$300 per bed, \$600 per set. (If the set is destroyed, i.e. a metal set that cannot stand alone as separate beds) (note – this is actual replacement cost of beds)
- Destruction of mattresses. \$100
- Discharge of fire extinguisher. \$50
- If any excessive cleaning is required a cost will be assessed and a bill sent.
- Any other damages that occur will be assessed and we will send a bill.

These standard costs apply to all camps of all kinds and were supplied to the Christian Education Department by Rev. Kevin Pierson, Executive Director, Springville Camp and Conference Center.

Each group attending camp must have an adult representative from their church sign this form and return it to the Christian Education Department with their camper and volunteer applications.

"We understand that if there are any damages done by leaders, volunteers, campers, or individuals associated with our church to the property of Camp Springville or the Christian Education Department, we are responsible for the costs as described above to repair the damages, or to replace any and all damaged items of any kind."
